2023 BUS TRANSPORT APPLICATION FORM

The Bridge House School bus provides a morning service from Stellenbosch and Pniel. Should you wish to make use of the service please read the following conditions and complete the application form attached.

- A completed Agreement form is required for all new enrolments and new Bridge House students wishing to use the service. This Agreement allows you to choose your collection point and agree to the payment and usage conditions.
- The terms of this Agreement will begin on the date of this Agreement and will remain in force and effect indefinitely until terminated as provided for in this Agreement or the student leaves the school.
- In the event that you wish to terminate this Agreement, you will be required to give one full term's notice in writing. Matric students are automatically excluded in the fourth term unless prior arrangements have been made with the school accounts department.
- Annual bus fee increases, effective in January of each new year, will be published during the 4th term of the current year.
- The school reserves the right to increase the cost of this service during the year. A full term's notice will be given of any increase.
- The school will invoice you on your school account on a termly basis and you will be required to pay the full amount within seven days of the start of each term. The school reserves the right to terminate this service if the school fee account is not kept up to date.
- Once a seat is booked for the term you will be required to pay the full amount for that term. No refunds will be given for illness, camps or if your child is unable to use the service for any reason on any particular day.
- The onus is on the parent to ensure that your child is on time for the bus every morning at the designated pick up point. The drivers are not permitted to wait for late comers or make deviations to other collection points.
- Occasional transport is offered only for visiting or exchange students and is subject to availability on each day. This must be arranged directly with the school administration, and the accounts department advised accordingly.

- A minimum number of students will be required to use the service to ensure the viability of the route.
- Please note it is important for you to inform Rhynie Van Schoor when there is any change to your daily routine with the bus service.
- Due to unforeseen circumstances, our bus driver may be substituted from time to time. The driver's primary job is to operate the bus safely. All students are required to respect and obey the driver's instructions at all times.
